Trump, Providence and Politics

His-Story: The Autobiography of God in the Affairs of Man

An assassin's bullet misses by an inch. Perhaps it determines the winner of an election. But if the bullet hits the mark, perhaps a nation descends into civil war. The historical impact is profound either way.

As of this blog, the answer as to who wins the USA November election cannot be known with certainty but the awareness of God's hand in governing the affairs of nations has certainly moved to the forefront of the public consciousness. For people of God, it is one of the most comforting doctrines of our faith.

Many of you know the book I co-authored with Stephen McDowell called *America's Providential History*. It's not primarily a book about America. It's a book about God's providence. [order here] The publisher is the Providence Foundation, which I founded in 1983 and McDowell still leads.

In our book we mention that at the Constitutional Convention in Philadelphia in 1787 it was one of the least orthodox Founders, Benjamin Franklin, who said: "...the longer I live, the more convincing proofs I see of this truth—that God governs in the affairs of men. And if a sparrow cannot fall to the ground without his notice, is it probable that an empire can rise without his aid?"

Before discussing the concept of Divine Providence, I want to make it clear that although I am an American who highly values our heritage, I know that the Kingdom of God is something not dependent on America. There have been many nations in history that were identified closely with God's Kingdom and yet they have disappeared or diminished greatly, yet the Kingdom survives. America is not my idol. I see it, as I do all nations, as creations of God, and I rightly have a duty to steward and love God's creation — even nations. I have been to over 70 countries and that is what I teach believers everywhere. There is no such thing as "manifest destiny" for only one special nation. God is working in all of them.

Nations first appeared in the Bible in Genesis chapter ten after God established civil government under Noah after the Flood. The special nation of Israel emerged two chapters later with God's call of Abraham. Many pagan nations and empires are also mentioned in the Old Testament with direct assertions that God sovereignly controls their leaders and actions. See several verses below:

Proverbs 16:9-10—"The mind of man plans his way, but the Lord directs his steps. A divine decision is in the lips of the king." Job 12:23—"He makes the nations great, then destroys them; He enlarges the nations, then leads them away." Psalms 22:28—"For the kingdom is the Lord's, and He rules over the nations." Daniel 2:21—"It is He who changes the times and the epochs; He removes kings and establishes kings." Daniel

4:17, 26—"The Most High is ruler over the realm of mankind;... Your kingdom will be assured to you after you recognize it is Heaven that rules."

And when Paul speaks in pagan Greece at Mars Hill in Athens he likewise declares that God made every nation and determines their time of existence and boundaries (Acts 17). And at the end of human history the New Testament focuses on God's final dealings with the nations of the world.

One of my personal pleasures throughout my adult life has been studying God's providence over nations in the era from the New Testament until today. Church Fathers such as the great African - Augustine of Hippo - wrote of God's providence in the history of men and nations in his book *City of God* after the sack of Rome in 410 A.D. Nations and empires can rise and fall but God's kingdom purposes endure.

I have collected rare books that used to freely speak of providential history. French historian Charles Rollin wrote Ancient History in the 1730s that was widely read by America's Founding Fathers. It stated that God is sovereign over history, but deals with nations dependent upon the heart and action of the people. He wrote:

"Nothing gives history a greater superiority to many branches of literature, than to see in a manner imprinted, in almost every page of it, the precious footsteps and shining proofs of this great truth, viz. that God disposes all events as Supreme Lord and Sovereign; that He alone determines the fate of kings and the duration of empires; and that he transfers the government of kingdoms from one nation to another because of the unrighteous dealings and wickedness committed therein."

But modern historians are afraid to express this. A historian who challenges that fear is someone I met a number of years ago while in Budapest is John O'Sullivan. He is a senior fellow at National Review Institute and a contributing editor of National Review. Yesterday, his article in NR titled *Providence and History* addressed the idea. He said:

"Miracles are beyond the historian's professional capacity. If an assassin's bullet went in a certain direction, we must assume that it was because his aim and the laws of physics pushed it in that direction. ... Assassinations have sometimes altered the course of history; the First World War arose from one. On [other] occasions, it was the failure of assassinations that may have altered history [such as Reagan, Pope John Paul II, and Thatcher]. ... Now, non-providential historians will naturally assume that the triple survival of president, pope, and prime minister were happy accidents... But what the historian should legitimately conclude and what the survivor of an attempted assassination may believe are two very different things. And what the survivor believes may then inspire him to undertake historical actions of the first importance."

What did Reagan conclude? "Whatever time I have left belongs to the Big Fella Upstairs." And Pope John Paul II said: "In the designs of Providence there are no mere coincidences." These men along with Thatcher worked closely

together in the years that followed to peacefully win the cold war. And America's Founders, legislators, military generals, and others frequently cited and credited God's providential aid which not only altered events, but inspired the courage and perseverance of those statesmen to win the War for Independence and a successful Revolution.

Sometimes God intervenes miraculously to aide certain leaders and nations and very positive results in history are fairly obvious. But sometimes God will allow terrible political and military leaders to prevail for a season. The result is often great suffering for people. But in the long run, a greater shift occurs in those seasons that ends up bringing a much deeper and long-lasting transformation.

An example is when the Protestant Reformation was happening in 16th century England. God used an ungodly king Henry VIII whose motives were not religious to establish the Church of England independent of the Roman Catholic Church. When his son succeeded to the throne he encouraged real reform, but soon died and Mary came into power. She ruthlessly imprisoned and killed many of the Protestants, and thousands fled the country for survival. Many thought the nation was lost. But many of these English Reformers found themselves in Geneva, learning from Calvin and his model of transformation that was having success. They published the Geneva Bible that included commentary notes on how to deal with tyranny and establish justice. Then, once they were better equipped, "Bloody Mary" died and Elizabeth ascended to the throne and welcomed the Reformers back. Eventually the Separatists arose and both Puritans and Pilgrims settled in America bringing the Geneva Bible and the worldview principles that were able to shape what became the United States on a unique foundation that blessed the world (despite slavery and other things that still required further reformation).

When divisions between the American colonies and the British King came to a head, a leader named George Washington stepped forward to lead what seemed to be an impossible task – to fight and defeat the powerful British military. But he knew the power of Providence in the affairs of man. A couple decades earlier as a British officer Washington was on the frontier fighting in the French and Indian War. At one point he had several horses shot out from under him, and multiple bullets go through his clothes and hat, and yet he was spared almost certain death. He acknowledged the hand of Providence in that moment.

There are multitudes of similar moments throughout many nations and certainly many more in America's history. America today has largely fallen away from its founding principles. Today Christian culture is no longer a majority influence. Christians are now even a persecuted minority in many places of USA. And the nation's two parties represent a seriously divided nation. Sometimes the divisions lead to radical actions of evil and it can be troubling to many people.

But the doctrine of Divine Providence means that no matter what happens, seemingly good or terribly bad, it does not justify hopelessness. Sometimes God let's evil run free to help many people to observe the fruit of it and come to their senses and turn in a new direction for national leadership. Perhaps 2020 was an election with cheating and fraud that led to the Biden's presidency. Perhaps God wanted to let things be seen for what they are before Trump is given another four years. But even if not, our eyes are on God. His Kingdom rules over all. Even if America continues to decline, the Kingdom of God does not fall with it.

A belief in Divine Providence does not excuse inaction or fatalism. Properly understood, it demands of us everything in our power to steward the nation in which we live for His glory. As Jesus commanded us: "Go and makes disciples of all nations" and Paul wrote: "Do not be overcome by evil but overcome evil with good." After Paul said to overcome evil with good he then said one key way to make that happen. He explained that government is established by God and then said that to have leaders in power who are faithful to punish evil is to have "ministers of God for good (Rom 13:4)."

God does not always require a devout Christian to be a minister of God for good in government. Sometimes he chooses pagans as His servants. Christians in an election matter. If they refrain from voting, they help ungodly leaders to prevail. We no longer have the privilege of living in a culture that has both political parties that put forth choices of two strong Christians to choose between. Yet if we demand too much of a leader in order to vote for him, we help the worst leaders prevail. Almost never in Israel's Biblical history did they have consistently moral and perfect leaders.

God's Providence in Politics is real. Sometimes it is life and death situations. Because He is at work, we must also act responsibly. Let's do what we can

Using God's Transcendent Ideals of Governance in the Bible

The Biblical Pattern for Evaluating Candidates Before Voting

Elections and voting are ideas that came from God. The Bible indicates that after Israel was released from slavery in Egypt that Moses gave to the people the right and duty to vote for their local city governors (called "judges" – Deut 1:9,13). This democratic component of Israel's government began about a thousand years before democracy was attempted in pagan Greece.

It was God's idea for holding government leaders accountable and empowering citizens. In the New Testament era the right to vote was only available among the Greeks and so the Apostle Paul seems to encourage Christians in Corinth to use this freedom to find better judges (1 Cor 6). And one of Paul's assistants named Erastus became an example of this when he became treasurer of the city through an election (Rom 16:23).

If God's people today have the freedom to vote then they also have a duty to use this for the best possible good in the governments of nations. But sometimes the best possible good is uncomfortable. The person or party we help is far from perfect, but the alternative is worse. And the idea that we

cannot in good conscience vote for someone who does not meet all the standards we hold to, only helps someone who is even further away from our standards. It perhaps makes us feel good about ourself to withhold our vote from an imperfect candidate, but it only harms our nation and our fellow-man.

How Did God Grade Government Leaders in Israel?

We have to get over our discomfort, because the enemy of the good is the idolatry of the perfect. In this world, we have no perfect nations because all men are sinners and all political systems are less than ideal. Israel in the Bible was chosen and led by God in one sense but was always a seriously flawed and sinful nation with government leaders who ranged from decent to horrific. Yet God still identified with them and did not let idolatry of the perfect keep Him from helping His chosen nation. Why should we?

Every king in Israel was given a grade. In Chronicles it summarizes their political actions and then ends by saying that either they did "right" or they did "evil." It almost never says they did "good" - only "right." There was a reason for this term. God did not expect a sinner in power to be "good" - only God is good. And in fact, often even kings who committed adultery or some other personal sin (such as David with Bathsheba) still received a grade that he did "right" meaning straight or within the guidelines.

How was the evaluation then determined? What were the guidelines for making a good grade? It was all based on if the king and his government lived in alignment or within the limits and purposes laid out in the Hebrew Constitution, otherwise known as the "Book of the Covenant." A king's personal life was important but not part of the criteria God used for the evaluation. So also, Christians today in our nations should not be voting for someone based on things in their personal life. It is not God's main measurement for governance.

So when comparing the USA presidential candidates (Harris and Trump) our vote has nothing to do with their marriages or their words or their manner with people. It is all about public policies. Are their proven actions while in government in the past in proximity to a Biblical worldview of governance or

not? Or which of the candidates come closer to that standard when evaluating their stated proposals or expressions of agreement with various political issues? Our modern nation does not have a constitution written by God Himself as Israel did, but is still a relatively useful standard for measuring candidates.

Ten Transcendent Ideals of Governance

God never expects us in America to copy every law in Israel's constitution for our modern governance. However, we can use the transcendent and universal principles for good government that were summarized in the Ten Commandments. These Ten principles were not strictly laws but a preamble (Exod 20:1-17) to Israel's complete constitution (Exod 20:18-chapter 23). These general ideals of good governance can be an evaluation tool for all nations today.

In <u>previous blog posts</u> I have explained that the Ten Commandments were not given primarily for individuals to know how to live. Rather, they were given to government leaders in Israel so they would know how they should govern. And mainly, they were stated negatively (i.e. "you shall NOT" do something) to put limits on government power and protect individual human rights. It was to maintain a small state which is the most basic difference of thinking today between pagan socialistic governance and Biblical government. [The way I interpret the Ten Commandments I found from various ancient Christian writers whose books are out of print. One rare modern book is *Democracy and the Ten Commandments* by Shinkoskey, although I differ with him on several points.]

So, without explaining here the details of each commandment as I did in earlier posts, I offer below a restatement of them in the form of questions we can ask ourselves.

Which candidate seems more inclined to use state power to:

...mix pagan or secular worldviews into their policy ideas? (Commandment 1; no other gods)

...favor unnatural or immoral sex, or require people to support or at least be silent about their beliefs or practices contrary to such activity? (Commandment 2; no images)

- ...undermine free choice in the marketplace; causing inflation, controlling prices, increasing taxes, etc? (C. 3; no misuse of God's name)
- ...hinder parents from home-schooling or religious schools; or hinder access to communications/media that contradicts ideologies favored by the state? (C. 4; no work once a week so that families can "remember" causes of slavery and freedom)
- ...protect and strengthen the rights of parents especially in education, sexuality, medical choices, etc? (C. 5; Honor father and mother)
- ...violate or fail to prosecute those who harm the life of citizens? (C. 6; no murder)
- ...violate or fail to prosecute those who harm the private property of citizens? (C. 7; no theft)
- ...violate or fail to prosecute those who harm natural marriage among citizens? (C. 8; no adultery)
- ...violate or fail to prosecute those who harm the justice system with false witnesses or biased prosecutions? (C. 9; no false witness)
- ...violate or fail to prosecute those who harm the private decisions of citizens in regard to everything else such as spouses, children, employees, property, speech, religion, etc? (C. 10; no coveting)

Take time to answer these and do research from reliable sources

For many people it is not easy to find trustworthy data to accurately make these evaluations. Almost certainly, you will not find it from random posts on social media! But there are some Christian organizations that compile comparisons of the candidates stand on certain issues. These can be helpful but are also not nuanced and can be biased. Another helpful evaluation is a comparison of the party platforms for general worldviews likely held by the candidates. But if you are diligent, you can do your own research.

About 80% of Evangelicals have been voting for Republicans for about thirty years now for a reason. This consistency shows that it is not about the person as much as it is the policies and philosophy of governance that has convinced Christians to vote in this consistent pattern for a while now.

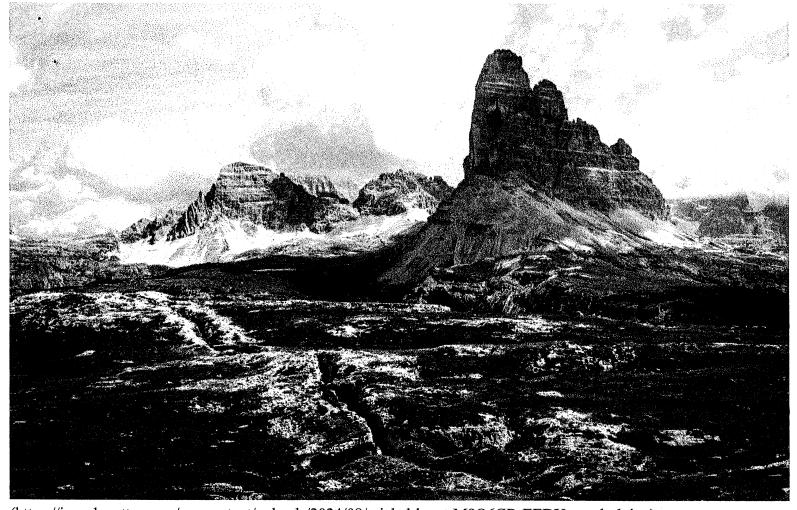

Part 1

As a non-partisan Christian, I have been encouraging Christians to vote for their values instead of voting based on groupthink and party affiliation. To do this, we have to go to the source of our ethics and values: the Bible.

God could not have made His standard for societal law any clearer than when He wrote His law in the Ten Commandme and gave it to Moses on Mount Sinai, as noted in Exodus 20. He laid them out in the order of importance as His top-ten These moral laws were given as a corporate blueprint to frame a policy for Israel and all nations so they may experience

national blessings.

These commandments are also the standard in both the New and Old Testaments for personal holiness and ethics. They repeated almost verbatim in the New Testament (e.g., Ephesians 6:1-3). Although we are not saved by obeying the work the law (Ephesians 2:8-9), they serve as the ethical behavior the Holy Spirit empowers us to walk in (Romans 8:4) when yield to His grace (Titus 2:11-12). Although the ceremonial aspect of the law has been done away with in Christ (John 1 Hebrews 9:1-10:14), the moral law is still the good, holy, and righteous standard for us to live by (Romans 3:31; 7:12, 1-25).

As we look at the Ten Commandments, we find two primary components related to our obligation to obey the law: the fi four commandments relate to our vertical obligation to God, and the last six commandments relate to our horizontal obligations toward our neighbors.

To save space, I will not quote all the commandments but will focus on several relevant to the upcoming election.

The first commandment is to have no other gods before Him (Exodus 20:3).

This is the most important of all the commandments because if we follow it, all the other commandments will naturally into place. Hence, I will only use this verse as related to our four stated commandments towards God.

Having no other gods before Him means that God has to be first and foremost in our lives, even as Matthew 6:33 instructure us to put His kingdom and righteousness first. In Matthew 22:37-38, we are called to love the Lord with all our heart, mosul, and strength.

Regarding the upcoming election: This means we are to put God's standards and Word above our ethnicity and gender (a it shouldn't matter whether a candidate is black, white, yellow, brown, or male or female), and we should put biblical va above our party affiliation.

As Dr. Martin Luther King alluded to in his "I Have a Dream" speech, we should judge candidates based on the "content their character rather than the color of their skin."

The last six commandments are about how we are to live in relation to fellow human beings. This was summarized in Matthew 22:39-40 when Jesus instructed us to love our neighbors even as we love ourselves. Thus, the first four commandments connect to Matthew 22:37-38, and the last six commandments connect to Matthew 22:39-40.

In reference to the last six commandments, we need to see how they directly relate to the public policy positions of each the political parties as well as each individual candidate.

"Honor your father and mother" (Exodus 20:12) is the most important commandment regarding human relations becaus connects to the nature of marriage and procreation. Marriage (Genesis 2:23-25) is the basic human building block of soc and existed before human government, (which started with God delegating capital punishment to humans in Genesis 9:5 before Israel, the Law of Moses, and the church.

It is also important to note that this commandment mentions both "father" and "mother," not "mother and mother" or "father and father." Thus, according to God's top-ten list, biblical marriage is the most important human institution we n to protect and honor, and is even mentioned before murder, adultery and economics!

Thus, political candidates who support same-sex marriage are in gross violation of the fifth commandment (which is also the first commandment related to human relations!)

The sixth commandment is "You shalt not murder" (Exodus 20:13).

God so hates the shedding of innocent blood (Proverbs 6:16-17) that murder is number two on His list of the remaining moral commandments related to human obligations.

Of course, if the platform of a political party or a candidate is pro-choice then they are in favor of a woman's right to terminate the life of an unborn child within her womb. What's even more troubling is that African-Americans and people color have been targeted the most by the abortion industry as noted by planned Parenthood founder Margaret Sanger, who believed people of color were from an inferior race, and, because they were poor, she planned to use "colored" ministers convince them from a religious perspective that the right thing to do was to terminate their pregnancies if they were too poor to afford them!

The seventh commandment, "You shall not commit adultery" (Exodus 20:14), basically teaches that all sexual acts outsi of the marriage of one man and one woman are considered adultery. The marriage bed, as defined by God's word, is undefiled (Hebrews 13:4). Leviticus 18 gets into more detail regarding how the seventh commandment is unpacked and illustrates how heterosexual sex with someone that is not one's spouse, with another person's spouse, with in-laws, same sex relations, as well as sex with animals, are forbidden by God. Paul the Apostle restates some of these sexual acts as si Romans 1:26-27 and 1 Corinthians 6:9-11.

Hence, same-sex marriage clearly violates two of the first three commandments related to human relations!

The eighth commandment, "You shall not steal" (Exodus 20:15), is related to economics.

This is where it gets sticky. Progressives claim that one of the major political parties favors the rich because, they say, the pay less of a percentage of taxes than the middle class. (The income tax percentage for the rich is higher than the middle class, but most rich people earn much of their income through capital gains, which are taxed much lower than salary income. However, all people have a right to buy and sell property and trade on the stock market. Thus, it is not a right reserved only for the rich. However, most poor people need to be financially knowledgeable or have enough money to no a living through capital gains categories like real estate and trading stocks.

On the other hand, I have heard some conservative people of color say that the Democrats are still attempting to keep the people on the plantation through entitlements and welfare programs that merely help in the short term but don't do enou to break the generational cycles of poverty. Other black leaders have noted how people of color have more poverty today related to marriage, intact families, and finances than before the Great Society programs of Lyndon Johnson started in the mid-1960s. This proves handouts and welfare have hurt more than helped people of color!

I believe a halfway approach is best: that government economic aid to the poor should continue, but that it should be redefined and restructured so there are far fewer blind handouts. I believe money should be funneled through partnership with churches, non-profits, and charities that have boots on the ground and know how to do micro-financing, job training entrepreneurial endeavors, and educate at-risk children. They would more likely do a better job than government bureaucrats.

With the current level of family fragmentation, non-profits, and church-based programs need to step up to the plate now more than ever because big government entitlement programs with no practical accountability have proven they cannot "parachute in" and rescue our communities!

Furthermore, by forbidding stealing in the eighth commandment, God espouses the right of individuals to own private property. Thus, this commandment is against any ideology (whether liberation theology or communism) that espouses economic egalitarianism, which is when an overreaching central government tries to force equality and the redistribution wealth by an extremely progressive tax structure or, in communism, by the abolition of private property altogether!

On the other hand, most conservatives in this nation are against redistribution and believe in empowering individual right and the free market. I believe this is more in line with scripture than those espousing communism and economic egalitarianism.

(I espouse a kingdom economic approach that not only includes a flat tax for everyone (i.e., like the biblical tithe) and a market view of capitalism but which obligates Christian business owners to disciple, finance, and reproduce other business owners from among their employees. This would do more than merely create jobs in poor urban areas; it would develop entrepreneurs who can break their generational cycles of poverty!)

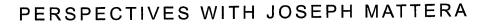
Furthermore, the tenth commandment, "You shall not covet your neighbor's goods" (Exodus 20:17), also seems to advant the theory of private property and is against the motive of egalitarianism, which many believe is driven by the politics of class warfare and envy.

Debating economic theory and what works would take a large position paper.

(I highly recommend black economist Thomas Sowell's book Basic Economics as a starter for this important subject.)

However, even if (hypothetically) progressives are correct in their position, the commandment dealing with economics i number eight on God's top-ten list, thus not as important as commandments 1-7. Furthermore, God tells believers that if they put His kingdom and righteousness first, He will provide everything we need anyway (Matthew 6:33).

Elections and voting are always a test for all believers: Are we going to vote on our biblical values as stated in God's top ten list, or will we vote on our race, ethnicity, and party affiliation? Suppose there is a situation in which candidates fron either party fall short of these moral and ethical standards. In that case, I believe the best person to vote for in a local or national election is the one that most favors biblical faith and a platform closest to upholding the essence of the Law of God.
